SUPPLY & DELIVERY OF VARIOUS MEDICINES FOR ELSIE GACHES VILLAGE OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT – NATIONAL CAPITAL REGION (DSWD-NCR)

1. The Department of Social Welfare and Development – National Capital Region intends to apply for the second time, the sum of **SIX HUNDRED TEN THOUSAND ONE HUNDRED TWENTY FOUR PESOS AND 10/100 (Php610,124.10)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply & Delivery of Various Medicines for Elsie Gaches Village of the Department of Social Welfare and Development-National Capital Region (DSWD-NCR)**.

Bids received in excess of the ABC shall be automatically rejected at bid opening. Late bids shall not be accepted.

2. A prospective bidder should have been in a business with dealings similar to this project for a period of at least five (5) years prior to the date of bid opening and should have completed within the last three (3) years from the date of submission and receipt of bids at least one (1) contract of similar nature amounting to at least fifty percent (50%) of the ABC.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".
4. The bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. The Invitation to Bid (ITB) may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and DSWD-NCR website at www.ncr.dswd.gov.ph.

The complete set of Bidding Documents may be acquired by interested Bidders starting 12 December 2014, 8:00 a.m. to 4:00 p.m., from the address below and upon payment of a non-refundable fee of Php1,000.00.

6. The DSWD-NCR BAC, considering the ABC, will no longer hold a Pre-Bidding Conference as indicated in Section 22.1 of the IRR of RA 9184. Bidders may directly coordinate with the BAC-Secretariat in the address below.

The opening of bids will be on 22 December 2014 at 9:00 a.m. at DSWD-NCR.
