INVITATION TO BID # 17-08-20

Supply and Delivery of General Merchandise for the Disaster Stockpile of the Department of Social Welfare and Development – National Capital Region (DSWD-NCR)(2nd time)

1. *The Department of Social Welfare and Development – National Capital Region intends to apply the sum of **ONE MILLION SIXTY TWO THOUSAND FOUR HUNDRED PESOS 0/100 (Php1,062,400.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of General Merchandise for the Disaster Stockpile of the Department of Social Welfare and Development – National Capital Region (DSWD-NCR)***

Bids received in excess of the ABC shall be automatically rejected at bid opening. Late bids shall not be accepted.

2. A prospective bidder should have been in a business with dealings similar to this project for a period of at least five (5) years prior to the date of bid opening and should have completed within the last three (3) years from the date of submission and receipt of bids at least one (1) contract of similar nature amounting to at least fifty percent (50%) of the ABC.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".
4. The bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. The Invitation to Bid (ITB) may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and DSWD-NCR website at www.ncr.dswd.gov.ph.

The complete set of Bidding Documents may be acquired by interested Bidders starting 16 August 2017, 1:00 p.m. to 5:00 p.m., from the address below and upon payment of a fee of Php 5,000.00, refundable in accordance to section 17.5 of the IRR.

6. The DSWD-NCR BAC will hold a ***Pre-Bidding Conference on 23 July 2017; 1:00 PM at Mini-OSEC Conference Room, DSWD-NCR 389 San Rafael cor. Legarda Streets, Sampaloc, Manila*** which shall be open to all interested bidders. Bidders are encouraged to send their authorized technical representative or personnel who are familiar with the bid requirements and will prepare the documents for the bidder. Bidders may directly coordinate with the BAC-Secretariat in the address below.

The opening of bids will be on 4 September 2017 at 10:00 A.M. at the RD's Conference, DSWD-NCR 389 San Rafael cor. Legarda Streets, Sampaloc, Manila
