

**INVITATION TO BID# 18-10-16**  
**SUPPLY AND DELIVERY OF LABOR AND MATERIALS FOR DESIGN AND BUILD FOR CONSTRUCTION OF REGIONAL REHABILITATION CENTER FOR YOUTH (RRCY) OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT – NATIONAL CAPITAL REGION (DSWD – NCR) 2ND TIME**

1. The Department of Social Welfare and Development – National Capital Region intends to apply the sum of **THIRTY MILLION PESOS (30,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and Delivery of Labor and Materials for Design and Build for Construction of Regional Rehabilitation Center for Youth (RRCY) of the Department of Social Welfare and Development – National Capital Region (DSWD – NCR).

Bids received in excess of the ABC shall be automatically rejected during the bid opening. Late bids shall not be accepted.

2. A prospective bidder Should have been in a business with dealings similar to this project for a period of at least three (3) years prior to the date of bid opening and should have completed at least one (1) contract of similar nature amounting to at least fifty percent (50%) of the total ABC of each LOT which the bidder opts to bid.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".
4. The bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. The Invitation to Bid (ITB) may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and DSWD-NCR website at [www.ncr.dswd.gov.ph](http://www.ncr.dswd.gov.ph).

***The complete set of Bidding Documents may be acquired by interested Bidders starting October 29 to November 9, 2018, 9:00 a.m. to 5:00 p.m. from the address below and upon payment of a fee based on the ABC of lots which a bidder opts to bid, refundable in accordance to Section 17.5 of the IRR.***

6. The DSWD-NCR BAC will hold a Pre-Bidding Conference on **30 October 2018; 1:00 P.M. at OSEC Conference Room, DSWD-NCR, 389 San Rafael St. cor. Legarda St. Sampaloc, Manila** which shall be open to all interested bidders. Bidders are encouraged to send their authorized technical representative or personnel who are familiar with the bid requirements and will prepare the documents for the bidder. Bidders may directly coordinate with the BAC-Secretariat in the address below.

**The opening of bids will be on 13 November 2018 at 9:00 A.M. at Karunungan Conference Room, DSWD-NCR, 389 San Rafael St. cor. Legarda St. Sampaloc, Manila.**
