

**INVITATION TO BID # 18-11-22**

**Supply and Delivery of Foodstuff Requirements of Residential Care Facilities (RCFs) of the Department of Social Welfare and Development – National Capital Region (DSWD-NCR) for the First (1<sup>st</sup>) Semester of year 2019**

1. *The Department of Social Welfare and Development – National Capital Region through the General Appropriation Act intends to apply the sum of:*

***LOT 1: Vegetables/Fruits and Other Miscellaneous***

***Contract Amount: Php9,263,597.75***

***LOT 2: Fish and Other Seafoods***

***Contract Amount: Php6,398,855.00***

***LOT 3: Meat/Pork and Beef***

***Contract Amount: Php9,344,815.00***

***LOT 4: Chicken and Eggs***

***Contract Amount: Php4,965,082.00***

***LOT 5: Canned Goods and Other Grocery Items***

***Contract Amount: Php8,399,077.00***

***LOT 6: Milk (Infant Formula)***

***Contract Amount: Php1,194,030.00***

*being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC shall be automatically rejected at bid opening. Late bids shall not be accepted.*

2. A prospective bidder should have been in a business with dealings similar to this project for a period of at least three (3) years prior to the date of bid opening and should have completed within the last three (3) years from the date of submission and receipt of bids at least one (1) contract of similar nature amounting to at least fifty percent (50%) of the ABC.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the “Government Procurement Reform Act”.
4. The bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. The Invitation to Bid (ITB) may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and DSWD-NCR website at [www.ncr.dswd.gov.ph](http://www.ncr.dswd.gov.ph).

***The complete set of Bidding Documents may be acquired by interested Bidders from November 27, 2018 to 14 December 2018 9:00 a.m. to 5:00 p.m. from the address below and upon payment of a fee based on the ABC of lots which a bidder opts to bid, refundable in accordance to Section 17.5 of the IRR.***

6. The DSWD-NCR BAC will hold a ***Pre-Bidding Conference on 04 December 2018; 9:00 A.M. at Karunungan Conference Room, DSWD-NCR 389 San Rafael cor. Legarda Streets, Sampaloc, Manila*** which shall be open to all interested bidders. Bidders are encouraged to send their authorized technical representative or personnel who are familiar with the bid requirements and will prepare the documents for the bidder. Bidders may directly coordinate with the BAC-Secretariat in the address below.
