I. INTRODUCTION

For the 3rd Quarter of the year 2010, the Region continuously upholds its commitment to serve the disadvantaged and marginalized sector of the society thru its effective and efficient delivery of programs and services. Part of this effort is the continuous implementation of various innovative social protection programs that serves as a flagship program of the new administration headed by Pres. Benigno Aquino in combating poverty such as Pantawid Pamilyang Pilipino Program (4Ps) and the National Household Targeting System for Poverty Reduction (NHSTPR)

To ensure the completeness of the NHST-PR database that all poor household will be included, On Demand Application (ODA) was implemented in seventeen (17) LGUs in the Region. This is to provide opportunity to those household which were not enumerated last year to be included in the database. A total of 146, 987 household or 170% against its targeted households of 86, 241 were registered as ODA applicants. Further, as of September 30, 2010, 53, 995 households or 36% against the total number of ODA receipts were already verified while the remaining 92, 992 households or 64% are continuously being verified by the Region.

Meanwhile, from the total number of 56, 241 ODA application verified by the program, 48, 142 households or 90% were already approved for household assessment while the 5, 853 households or 10% were already found and included in the NHST-PR database. Aside from that, continuous conduct of orientation and coordination up to the barangay level as well as information dissemination campaign thru TV and Radio guestings are being done by the Region

Furthermore, Pantawid Pamilyang Pilipino Program focuses its' activities on the conduct of community assemblies for the validation and registration of 4Ps beneficiaries in Set 3 areas composed of nine (9) LGUs with 13, 607 potential households targeted. The Region was able to register 9, 046 families/ households achieving a 66.40% accomplishment rate. The Region also initiated the Search of Huwarang Pamilyang Pilipino ng 4Ps which aims to advocate the positive gains of the program, promote responsible parenting among the program beneficiaries as well as recognize the significant contribution of the 4Ps beneficiaries in meeting the program conditionality. The eight (8) families from eight (8) LGUs were recognized and awarded during the celebration of Family Week at SM Mall of Asia. Lastly, the program was also able to accomplish the compliance verification for Set 1 areas and updating of the data of beneficiaries in the system.

On the other hand, the Region also strengthens its effort in responding to the emerging concerns along trafficking in person. As part of the Region's strategy in strengthening implementation of RA 9208 otherwise known as "Anti-Trafficking in Person Act, in partnership with the members of the Inter-Agency Council against Trafficking (IACAT) established a NAIA Task Force against Trafficking in Person (NAIATFATP) at NAIA Terminal to assist, provide support and necessary intervention to victim/would be

victims of trafficking. This is in support to the advocacy of the government in significantly reduce, if not eliminate, human trafficking activities in the Philippines as well as create an integrated database of records as well as develop a comprehensive and responsive system for human trafficking investigation.

Lastly, in the performance of the Department's mandate to deliver protective services to community and center-based clients, the Region continuous the operation of twelve (12) Centers/ Institutions which served a total 3, 117 and pursue provision of necessary interventions thru community based program to 37, 702 actual served beneficiaries.

II. HIGHLIGHTS OF ACCOMPLISHMENTS

A. SERVICES RELATING TO THE FORMULATION AND ADVOCACY OF POLICIES AND PLANS AND PROGRAMS

1. Policy and Plans Development

1.1 Sectoral Programs

a. Children Welfare Program

Regional Committee for the Welfare of Children (RCWC)

RCWC held its 3rd Quarter Meeting last August 25, 2010. This was attended by eleven (11) member agencies. Outputs of the meting are the following

- o Finalized Communication Plan for the Bright Child Campaign
- o Approval of RAC resolution declaring Makati City as the Regional Winner of the 2009 Search for the Most Child Friendly City
- o Formulated Plan for the celebration of Children's Month this October

b. Women Welfare Program

Regional Inter-Agency Committee against Trafficking and Violence against Women and the Children (RIACT-VAWC)

Synchronized Meeting of Regional Inter-Agency Committee against Trafficking and Violence against Women and the Children (RIAC-VAWC) and Regional Inter-Agency for the Filipino Family (RIAC-FF)

- The meeting was held last August 25, 2010 at the National Housing Authority (NHA) Operating Center, Diliman Quezon City which was participated by ten (10) member agencies. The meeting provided venue to discuss updates on the following:
 - o Action Points for the creation of City/ Local Inter-Agency Committee on Anti-Trafficking (C/LIACATA) in very cities in National Capital Region
 - o Year-End Evaluation and Planning Workshop

c. Youth Welfare Program

A consultation meeting with Social Workers Handling Court Related cases was held last September 29, 2010 at the Unibersidad de Manila which was participated by ten (10) LGUs, two (2) NGOs and DSWD-NCR. The meeting provided venue to discuss updates of the following:

- Updated in jail monitoring visit conducted by DSWD- NCR on sixty-eight (68) jails in NCR
- o Sharing on the Guidelines for After-Care Services to released CICLs.
- Planning on action to be taken by LGU in responding to the concerns of children detained in adult jails as well as targeted beneficiaries for the after-care services

Monitoring of RA 9344 "Juvenile Justice Welfare Act"

Jail Monitoring was conducted to sixty-eight (68) jails in NCR. Per result of the monitoring, it was found out that there were twenty (20) minors in the adult jails in seven (7) LGUs namely Navotas, Manila, Mandaluyong, Muntinlupa, Malabon, Pasig and Caloocan. The results were coordinated and properly endorsed to all C/SWDOs of the aforementioned LGUs. The Region isdoing follow through on the action taken by the LGUs on the findings

Advocacy to Compliance to SWD Laws

Orientation on the salient provision of RA 9344 and promotion of the "Project Helpline" was conducted thru guesting in the morning show "At Ur Serbis" at NBN TV 4 $\,$

Celebration of Special Events

In commemoration of the celebration of PYAP Day nationwide, the Region, together with the Pag-Asa Youth Association of NCR (PYAP-NCR) held the PYAP Day Celebration on July 31, 2010. The activity, which was hosted by LGU Pasig, was participated by six hundred sixty-on (661) youths from twelve (12) LGUs in NCR and DSWD-NCR. One of the highlights of the activity was the awarding of winners in various sports activities participated by LGUs as well as the announcement of the winner of the On-the Spot Logo Making Contest in which will be the official logo of the Regional Sub-Committee on the Welfare of Children (RSCWC). Makati City won the said contest wherein they were given cash prize and token from DSWD-NCR and RSCWC.

d. Family Welfare Program

Regional Inter-Agency for the Filipino Family (RIAC-FF)

Synchronized Meeting of Regional Inter-Agency Committee against Trafficking and Violence against Women and the Children (RIAC-VAWC) and Regional Inter-Agency for the Filipino Family (RIAC-FF)

The meeting was held last August 25, 2010 at the National Housing Authority (NHA) Operating Center, Diliman Quezon City which was participated by ten (10) member agencies. The meeting provided venue to discuss updates of the following:

- Status of the implementation of the Regional Development Plan for the Filipino Family of Inter-Agency Committee (RDPFF-IAC)
- Updates on the Pantawid Pamilyang Pilipino Program (4Ps)
 Implementation
- Sharing on the status of the Action Plan formulated during the Leadership Package on the Parent Education on Adolescent Training of the inter-agency committee members.
- o Preparation for the Family Week Celebration

Celebration of Special Events

The Family Day Celebration of the Regional Inter -Agency Committee for the Filipino Family (RIAC-FF) was held last September 25, 2010 at the Music Hall, SM Mall of Asia, Pasay City. The activity was attended by two hundred seventy six (276) beneficiaries of the 4Ps from eleven (11) LGUs as well as Two Hundred Seventy Seven (277) delegates from fifteen (15) member agencies. The event, which was hosted by Mr. Erwin Tulfo, was also graced by the Undersecretary of Operations and Capacity Building Group (OCBG) Ms. Celia Capadocia-Yangco and the DSWD-NCR Director III/ Officer In-Charge Ms. Patricia B. Luna. Highlights of the activity were as follows:

- Awarding of the Regional Huwarang Pamilyang Pilipihno Winner and the nominated families. The said prestigious award was given to the "Manuel Family" from Pasay City in which they were awarded with Php. 15,000 in cash and gift packs from the Region.
- Awarding of the winners for the Jingle Making Contest. Among the five (5) entries, City Social Welfare and Development Office-Mandaluyong City was adjudged the winner of the contest with the jingle title "Kayang Kaya ng Pinoy"
- o Set-up of booths showcasing the programs and services being provided by the member agencies towards family development.

e. Older Person Program

Regional Coordinating and Monitoring Board (RCMB)

RCMB's 3rd Quarter Meeting was held last July 27, 2010 at the Bulwagang Amoranto, Quezon City Hall, Quezon City which was participated by seven (7) representatives from three (3) member agencies. Highlights of the meeting were as follows:

- Finalization of RCMB Composition
- o Updating on RCMB Accomplishment for 1st Semester CY 2010
- o Issues and concerns in the Implementation of RA 9994

f. Persons with Disabilities

Regional Council for Disability Affairs (RCDA)

- RCDA's held its 3rd Quarter Meeting on July 2, 2010 at the DepEd Conference Hall, DepEd-NCR, Bago Bantay Quezon City. The activity was attended by thirty-nine participants from nineteen (19) member agencies, twelve (12) C/MSWDOs, three (3) NGOs. The said meeting served as venue for the participants to be informed and updated on the following:
 - o DepEd programs and services to children with disabilities
 - DepEd statistics of children enrolled in SPED
 - o Preparatory activities for the upcoming NDPR Week
- Another meeting was conducted last September 7, 2010 at the DSWD-NCR Conference Room, Manila which was participated by 27 representatives from thirteen (13) member agencies. The following were the highlights of the meeting:
 - Review of United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) and the National Human Rights Action Plan (NHRAP)
 - Data Collection and Planning for the Conduct of Accessibility Audit to Selected Public Infrastructure in Metro Manila

Advocacy to Compliance to Laws

An orientation on the salient provisions of Batas Pambansa 344 of the "Accessibility Law' was conducted by the Region last July 2, 2010 at the DepEd Conference Hall, DepEd-NCR, Bago Bantay Quezon City. The activity was attended by thirty-nine participants from nineteen (19) member agencies, twelve (12) C/MSWDOs, three (3) NGOs and DSWD- NCR. Mr. Jim Silva, one of the resource speakers from the United Architect of the Philippines, provided the salient provisions of the said law, highlighting the need to comply with it. Further, Mr. Amand Michael Euistaquio from the United Architect of the Philippines also provided information to the participants on how to conduct

access audit. He also shared the key consideration in the conduct of access audit. An actual access audit was also done in the premise of the venue as part of the session.

Part of the expected output of the orientation is for the members of the interagency to be able to conduct self-access audit in their respective offices.

1.2. Consultation Dialogues with C/MSWDO

For the 3rd quarter, the C/MSWDO consultation dialogue was held on August 6, 2010 at the Church of Jesus Christ of the Alter Day Saints, Malinta, Valenzuela City which was attended by the Local Social Welfare Officers / representatives from the thirteen (13) LGUs and eleven (11) DSWD- NCR staff with the following main concerns discussed:

- DSWD and LGU Partnership along Technical Assistance and Resource Augmentation (TARA)
- Guidelines of DSWD and LGU Referral of Clients
- Status of compliance to RA 9344 and RA 9442
- Sharing on the status of the National Referral System (NRS) and National Recovery and Reintegration Database (NRRD) for Trafficking Person
- Sharing on the updates on Pantawid Pamilyang Pilipino Program (4Ps) and the National Household Targeting System for Poverty reduction (NHST-PR)
- Sharing on the finding of Human Rights Advisory (CHR) on the Continuing of Detaining in Jail and Police Precincts
- Updating of LGU List of Disaster Prone Areas
- Sharing on the IDCB Activities of the FO-NCR involving LGUs
- Sharing on the new project of PAFPI "Most at Risk Children and Youth at Quezon City and Manila (MARCY)

1.3 Review of Manual of Operations/Existing Guidelines/Draft Manuals as Proposed by Units/Centers/Institutions

The Regional Policy Development and Review Committee (PDRC) reviewed and provided comments/ inputs to five (5) proposed policies/ guidelines submitted by the concerned centers/ institutions consisting of four (4) policies/ guidelines and one (1) Manual of Operation as follows:

- 1. INA Healing Center's Guidelines on the Use of Endowment Funds
- 2. INA Healing Center's Manual of Operation
- 3. NVRC's Guidelines on the Provision of Gratuity
- 4. *C/I Coordinator's Guidelines on Escorting of Clients*
- 5. CRADLE's Guidelines on the After-Care Services for Released CICL

All the five (5) submitted draft policies were deliberated by the PDRC. Out of these five (5) deliberated policies, the INA Healing Center's Guideline on the Use of Endowment Funds and CRADLE's Guidelines on the After-Care Services to Released CICL are for final approval at the ManCom. The rest were already returned to the concerned proponents for enhancement.

Moreover, the Region provided its comments/ recommendation on the five (5) draft guidelines/ policies endorsed by CO for comments:

- 1. Draft Policy on the Assignment of Center Heads Based on the Classification of DSWD Centers and Residential Care Facilities
- 2. Enhanced Guidelines on the Management of emergency Shelters/ Evacuation Centers
- 3. Draft Internal Guidelines in the Implementation of RA 9803 "Food Donation Act of 2009"
- 4. Proposed Draft Amendment to AO 5 series of 2008 "Omnibus Guidelines" on the Management of DSWD- Operated Crisis Intervention Unit
- 5. Enhanced Policy for the Conduct of Studies/ Researchers in DSWD Office, Centers and Institutions

1.4. Policy Fora/Dialogues/Lectures Conducted

A SWD Forum entitled "Government Response to Rapid Urbanization" was conducted last September 21, 2010 which was attended by ten (10) LGUs, three (3) NGOs, three (3) NGAs and fourteen (14) DSWD- NCR Staff. The activity was held at the Pamantasan ng Lungsod ng Manynila (PLM), Intramuros Manila.

The forum provided the participants an opportunity to be informed on programs and services or government interventions to rapid urbanization. Mr. Roberto G. Villa, Technical Consultant to the Secretary and Lead Convenor of the National Anti-Poverty Commission (NAPC) shared the program and services of NAPC in response to rapid urbanization, particularly along implementation of RA 8425 "Social reform and Poverty Alleviation Act"

Two of the invited reactors, Dr. Irma L. Asuncion, Regional Director of Center for Health Development, Department of Health and Mr. Jose Reynaldo B. Lunas, Planning Officer IV of Metro Manila Development Authority (MMDA) also shared their respective reaction on the presented programs and services of NAPC.

As a result, there is a need to streamline the programs and services to focus on one direction to achieve the common goal. Likewise, NAPC as the lead agency to find ways to implement projects using the top to bottom approach involving the national agencies and bottom to top approach involving the cities/ municipalities in the participatory decision making. In relation to relocates.

3. National Household Targeting System

For this quarter, the National Household Targeting System for Poverty reduction (NHTSPR) started its On-Demand Application (ODA) to provide an opportunity for the household who were not included or assessed during the regular enumeration conducted from April 2009 to March 2010 to be included in the project's database. Advocacy campaign and information dissemination drive on the conduct of On Demand Application (ODA) was also conducted up to the level of barangays.

In relation to the implementation of the On Demand Application, the following activities were conducted by the Region:

- Orientation of LGUs on the implementation and process flow of On Demand Application which has was attended by representatives from sixteen (16) cities/ municipality last August 12, 2010 at the Bulwagan Amoranto Hall, Quezon City.
- Pilot testing of On Demand Application in Brgy. Commonwealth on August 23, 2010 which was attended by ten (10) LGU representatives and four (4) NPMO Observers.
- Distribution of IEC materials to 1, 705 barangays
- Orientation on the On-Demand Application (ODA) and its process flow was conducted to barangay official from seventeen (17) LGUs in NCR on August 17-18, 2010. Out of the 1, 705 targeted brangays officials, 1, 261 braangay official or 73% attended the said orientation.

On Demand Application (ODA) was implemented in seventeen (17) LGUs in NCR from August 25- September 8, 2010 wherein 146, 987 ODA applicants were registered or 170% against its targeted household for ODA which is 86, 241

Out of the total number of 146, 987 ODA receipts, 53, 955 or 36% were already verified. Meanwhile, the Region is still verifying the remaining 92, 992 households or 64%.

From the total number of verified ODA receipts, 48, 142 of 90% were approved for household assessments while the remaining 5, 853 households or 10% were already found and included in the NHST-PR database.

4. Research

Regional initiated research entitled "Out of the Center and Into the Streets: How Repeatedly Clients Find their Way Back to Homelessness"

The Region's report on the research initiated "Out of the Center and Into the Streets: How Repeatedly Clients Find their Way Back to Homelessness" is continuously being revised and enhanced based on the inputs/ comments of the DWD Central Office. Further, findings of the research will be presented to the respondents involved in the research and other stakeholders for the purpose of validating the results and findings and to solicit further inputs from them within October 2010.

Assessment of Research Request

For this Quarter, the Region was able to orient thirty-six (36) walk-in students/ researchers regarding research protocols and guidelines. Out of the thirty-six 36), six (6) or 16% of the researchers submitted request to conduct research in DSWD. Out of the six (6), only one (1) was endorsed to DSWD-CO upon favorable assessment of FO while the remaining five (5) were returned to the proponent for enhancement and completion of the requirements. As of this time, the Region is still awaiting for the approval of the said research proposal.

B. STANDARDS SETTING

The Standards Unit ensures the registration, licensing and monitoring of standards compliance of NGOs and accreditation of service providers such as Day Care Workers, Marriage Counselors and Court Social Workers and has accomplished the following:

Social Welfare and Development Agency (SWDA)

Assessed and Registered

For the 3rd quarter of CY 2010, out of eighteen (18) SWDAs target, the Region have **assessed and registered** thirteen (13) SWDAs. The registered SWDAs are people's organization and resource agencies situated in eleven (11) LGUs which provide Medical/Dental Mission, Livelihood Program, Trainings and Skills Development, Scholarship Program and Community Outreach.

Assessed and Licensed

The Region has issued Registration Certificates and License to Operate to twelve (12) SWDAs. Eight (8) of them renewed their licensed while four (4) are newly registered and licensed. Three (3) SWDAs operate in Manila and Quezon City, two (2) SWDAs at Mandaluyong and one (1) operates in Pasig, Malabon, Las Piñas, and Parañaque. The licensed SWDAs caters to all the marginalized sectors.

Assessed and Accredited

Out of the six (6) target SWDAs for accreditation the Region have assessed thirteen (13) Residential SWDAs which consists of seven (7) NGOs and six (6) LGU-Facilities. The six (6) LGU-Facilities are from Mandaluyong with one (1), two (2) from Makati and three (3) in Manila. These centers accommodate and provide temporary shelter to children and older persons in need of special protection. While on NGOs, three (3)

of them operates in Region III, V, VIII, X, XII, CAR and CARAGA and four (4) merely operates in National Capital Region.

On ABSNET

The five (5) clusters of ABSNET-NCR were able to conduct its regular quarterly meetings. During the meeting, project proposal in line with their special advocacy to showcase their programs and services was discussed, orientations on AO 17 and 18 series of 2008 was conducted and provision of technical assistance to NGOs who were previously registered, licensed and accredited by the Department but have not yet complied to the new guidelines.

On Accreditation of Service Providers

Social Workers Handling Court Related Cases

Out of the two (2) target Social Workers Handling Court Related Cases, the Region had accomplished 50% or pre-assessed only one (1) Social Worker Handling Court Related Cases for accreditation after having met the minimum requirements for accreditation and the documents were forwarded Standards Bureau. Continuous follow up is being conducted by the Region in encouraging the organic staff to be accredited.

Pre-Marriage Counselors

For this quarter, no Pre-Marriage Counselors applied for accreditation since they preferred to attend first to Roll Out of Pre-Marriage Counselors Training conducted by Population Commission (POPCOM). Said training focused further on the use of revised PMC Manual specifically the content and process guidelines.

Day Care Workers

The Region has accredited thirty-five (35) Day Care Workers out of thirty-nine (39) targets which is 90% accomplishment. Eighteen (18) DCWs are from Parañaque and seventeen (17) from Taguig City.

An orientation on the "Revised Manual for Day Care Workers, Checklist and Accreditation Tool was conducted to Community Resource Center of Marker of Light for the Marginalized Sector, Inc. which lead to compliance of the said SWDA to the said manual.

Technical assistance was also provided by the Region on the compliance of requirements for renewal and accreditation of Department of Foreign Affairs, Social Security System and LandBank Day Care Centers.

Accreditation of DSWD Facilities

On the status of accreditation of Center/Institutions (C/Is) of the Region, out of the eleven (11) C/Is, three (3) were accredited, (1) for renewal and seven (7) are for compliance. Said C/Is are presently complying on the recommendation of Standards Unit and Bureau such as securing updated safety clearance of the center and installation of fire exits whereas on Program and Case Management C/Is are required to submit the enhanced Manual of Operation and updates on profile and inventory of clients.

For Public Solicitation

Nationwide Fund Campaigns, there were three (3) SWDAs applied for the Nationwide Fund Drive, out of the three (3), two (2) are registered and licensed. The methodologies being used by the SWDAs are distribution of letters of appeal, selling of tickets, mass media campaign, sending of text messages and conduct of rummage sale to complement and support the National Tuberculosis Control Program of the government and to augment the agency's resources in the implementation of its programs and services.

Local Fund Campaigns, there are six (6) applicants for the Regional Solicitation Permit. Two (2) of the applicants are registered, licensed and accredited SWDAs which provides residential care programs for sexually abused girls and street boys and girls. On the other hand, four (4) SWDAs are registered with the Securities and Exchange Commission. Purpose of fund campaign of these SWDAs is to raise funds to augment their resources for the implementation of their programs and services.

With the continuous partnership of the Region with the Philippine National Police and other stakeholders in the implementation of the Public Solicitation Law, the Field Office received three (3) sample letter of illegal solicitation from the target donors. The Field Office has sent official communication to the illegal solicitors advising them to comply with the requirements per AO 14 series of 2007 or the Revised Omnibus on Rules and Regulations on Public Solicitation.

Duty Free Entry of Foreign Donations, the Region received one (1) application for endorsement for Duty Free Entry of Foreign Donation. Targeted beneficiaries are from Malabon and Manila consisting of 18,624 indigent children.

The Region has monitored the distribution of food supplements by one (1) NGO at Makati City for the third time with updates and one (1) NGO was able to complete its summary distribution report both forwarded to Standards Bureau.

C. SUPPORT SERVICES AND TECHNICAL ASSISTANCE TO INTERMEDIARIES

Orientation, Meetings, Seminars and Trainings

To ensure that the different SWD programs and services of the Department are effectively and efficiently implemented by our intermediaries, the region, through its Institutional Development Unit and other concerned units regularly and continuously conduct activities that will provide opportunity to enhance the capacities and knowledge of our intermediaries. These activities also serve as venue in addressing the issues and concerns raised by our partner agencies and providing the necessary recommendations thereof as well as to strengthen the delivery of services to beneficiaries.

For this quarter, the following trainings/orientations/seminars/meetings for intermediaries were conducted:

- ❖ As shown by the table above, a total of twenty (20) disaster occurrences happened during the 3rd Quarter which affected a total of four thousand four hundred forty six (4,446) families or twenty one thousand two hundred eighty eight (21,288) individuals.
- ❖ Family packs of assorted foodstuff have been provided to the victims of the fire and typhoon incidents by the Region. A total of Php 10,687,618.00 augmentation support was provided by the Region thru the legislators, the Local Government Unit's C/MSWDOs and non-government organizations (NGOs). The affected cities were Makati, Las Piñas, Malabon, Manila, Valenzuela, Muntinlupa, Parañaque, Caloocan, Navotas, Pasig, Pateros and Quezon City.

Special Projects

Health and Nutrition

a. Supplemental Feeding Program under Kabisig ng Kalahi

❖ To date, a total of thirty (30) modules with a total of 900 malnourished children beneficiaries are being monitored by the Special Project Unit Staffs in eight (8) LGUS namely Pateros, Manila, Taguig, Caloocan, Las Piñas, Mandaluyong, Quezon City and Pasig.

b. Food for School Program

- ❖ As of June 2010, the Region has served a total of 291, 078 day care children amounting to Php635, 737, 455.50.
- The Region has initially submitted to PMB CO the target beneficiaries from 1,804 DCCs in 17 LGUs with a total of 149,902 enrollees for October to December 2010 feeding

Education

a. PGMA Scholarship/Educational Assistance Program

a.1 SONA Kid and Family

❖ The Region coordinated with CHED-NCR for possible inclusion of Mr. Erwin Dolera to their scholarship program under the "study now, pay later" scheme for SY 2011-2012. CHED-NCR is supposed to provide Php7, 500 per semester. However, Mr. Dolera and his sister expressed that they are no longer interested with the offer of CHED-NCR as the President of St. Lukes Hospital, friend of the former President Gloria Arroyo assured them that he will shoulder the full tuition fee of Erwin for SY 2011-2012.

a.2 PGMA Tertiary Scholarship Program

* This project was terminated last June 15, 2010. During the eight (8) years of program implementation, a total of 1,179 beneficiaries/scholars graduated from PUP-TUP. Eleven (11) scholars received exemplary recognition (four (4) from TUP and seven (7) from PUP).

a.3 Children and Youth of Payatas

❖ A total amount of Php935, 000.00 was released to the region by the PMS-Presidential Social Fund for the 51children/youth beneficiaries of PGMA-EAP. Forty one (41) children received Php20, 000.00 each, eight (8) children received Php10, 000.00 each and two (2) received Php2, 500.00 each.

a.4 Payatas Victims

❖ The educational assistance for 3rd and 4th tranche for SY 2008-2009 and 1st and 4th tranche for SY 2009-2010 was already provided by the Region to the beneficiaries.

a.5 Metro Bank Foundation Inc. Scholarship Program

❖ Out of the 20 original scholars since SY 2007-2008, one (1) waived his scholarship, three (3) failed to reach above 85% general weight average and 16 continuously availing the scholarship in TUP (8) and PUP (8).

b. Petron Tulong Aral Program

❖ As of June 29, 2010, a total of 4, 651 scholars were supported by the Petron Foundation. Out of this, 4, 269 were from elementary and 382 from high school level. For high school level, 284 were supported by Petron employees while 98 were sponsored by Landbank of the Philippines.

c. Skills 2D Max Project

❖ To date, a total of ninety one (91) students are enrolled in three (3) partner vocational schools namely DATAMEX Computer College (21), Muntinlupa City Technical Institute (25) and Guzman College of Science and Technology (45).

Other Programs

a. Pantawid Pamilyang Pilipino Program or 4Ps

Conducted courtesy calls to the new Local Chief Executives of Marikina and Makati City regarding the implementation of 4Ps.

- Out of the 13, 845 household beneficiaries for Set 1, only 9, 252 received their grants thru cash card while 386 households received their grants thru over the counter (OTC).
- ❖ A total of 4, 208 beneficiaries did not received their grants due to the following reasons:
 - ✓ Non -compliance to conditionalities on education and health
 - ✓ Bneficiaries are still for verification if they are still residing in the area or still have 0-14 years old children.
- ❖ Pateros initial grant is still on hold status. Payment shall be simultaneously downloaded together with the nine (9) cities under Set 3 areas.
- Out of the 13, 607 potential beneficiaries for Set 3, only 9, 046 household were validated and registered.
- ❖ A total of 4, 561 potential households were not registered due to the following reasons:
 - ✓ No 0-14 years old children
 - ✓ Transfer of residence and relocation due to demolition
- ❖ The signing and endorsement of the 4Ps beneficiaries (Set 3) accomplished LBP forms is on-going.
- ❖ Supply side data of Set 1 areas were updated in preparation for the orientation on 4Ps and presentation of Supply Assessment Results to newly elected officials. Likewise, supply side assessment was facilitated in the Set 3 LGUs to determine the readiness and capability of the LGUs to support the possible increase in demand on both health and education.
- Conducted Family Development Sessions (FDS) to Set 1 parent groups to enhance their knowledge and skills as well as to help them appreciate and respond to health and education conditionalities of the program.
- ❖ Conducted Compliance Verification System for the 2nd quarter of 2010 to validate if the beneficiaries have complied the conditions of the program.

b. Sagip Kalinga Project

❖ A total of 500 street children were provided of educational assistance amounting to Php2, 000.00 each.

- ❖ Sixteen (16) minors were rescued by the Parañaque CSWDO. Dialogues/meetings were conducted with the parents of the minors and reminded them to ensure safety of their children. CSWDO conducted series of interviews and assessment on the families of the rescued minors. Likewise, coordination with the Barangay officials was done to ensure regular patrolling of the area.
- ❖ In Makati City, a total of ninety (90) individuals were also rescued. Fourteen (14) rescued street children/dwellers were referred to different LGUs and institutions such as DSWD-Parañaque (6), DSWD-Quezon City (1), DSWD-Manila (2), NCMH (2) and MSWD Drop-in Center (3). Seventy six (76) were returned to their families after presenting necessary documents from the parents and guardians. Orientation on Anti-Mendicancy Law, signing of agreement between the LGU and the parent/guardian of the 76 street children/rescued adults were also conducted.
- ❖ A total of 63 street children/dwellers were also rescued and temporarily sheltered at Muntinlupa Social Development Center (MSDC). Out of 63, 16 minors were endorsed to their respective LGUs, 26 street children/adults were returned to their respective families in Las Piñas while 21 were residents of Muntinlupa City. A consultation meeting was conducted by the region with CSWDO-Las Piñas and Muntinlupa City together with barangay officials. A sustainable plan of activities was discussed to prevent the recurring of street children at Madrigal Avenue corner Alabang Zapote road.

D. DIRECT SERVICES TO COMMUNITY-BASED CLIENTS

Community Based Services

The Region continuously caters to children and women in difficult circumstances (CEDC/WEDC) and persons with HIV/AIDS (PHAs) thru counseling, provision of psychological, psychiatric, legal/consultation, transportation and financial assistance.

A total of 11, 001 clients were served by the Crisis Intervention Unit amounting to Php 22, 655, 541.67 in various forms of assistance as shown in the table above. The table also shows that medical assistance ranks number one in terms of provision of assistance to our clients in crisis situation with 50% fund utilized from the total amount of assistance provided followed by burial assistance which is 22% of the total amount.

NAIA Task Force against Trafficking in Persons (NAIATFATP)

- ❖ NAIATFATP served eleven (11) clients victims of trafficking for the month of September. Most of them are from Zamboanga and supposed to work as domestic helpers in Riyadh, Saudi Arabia and Lebanon.
- ❖ They were all provided of psychosocial counseling. Five (5) of them were also referred to Visayan Forum Foundation Inc. for temporary shelter and to the Department of Justice (DOJ) for legal assistance. Five (5) were reintegrated to their respective family and one (1) was referred to Crisis Intervention Unit for transportation assistance back to her/his province.

Adoption Resource and Referral Unit

For this quarter, the Region served 312 carry-over cases and 154 new cases with a total of 466 cases. Of these, 4 were assessed and endorsed to ICAB, 69 were placed thru alternative parental care and 34 were issued certification declaring a child legally available for adoption while 359 are still under review.

Further, the Aruga at Kalinga sa mga Bata sa Barangay continuously provide foster care to nine (9) children with seven (7) foster families.

Minors Traveling Abroad

For this quarter, the Travel Clearance Unit has served a total of 1,508 clients applying for travel clearance permit wherein 725 are male and 783 are female. Amount raised was nine hundred fifty thousand two hundred pesos (460, 700.00).

E. DIRECT SERVICES TO CENTER-BASED CLIENTS

Jose Fabella Center (JFC)

Jose Fabella Center has served 1,365 clients for this quarter making a total 3,891 clients as of the 3rd quarter of CY 2010 or 86% of the annual target which is 4,500 clients. Disaggregated by their sector, there are 1,029 adults, 307 children, 29 PWDs new clients. Further, among these new clients, 1,037 are vagrants, 276 are transients and 52 are mendicants.

Among the highlights of accomplishment of JFC for this quarter are the following:

- Conducted staff-clients dialogue in which it aims to let the clients share and facilitate problems they are encountering specifically with regard to the lengthy stay in the center. The said activity enables the clients to verbalize their issues/concern in the center as well as to address their concerns.
- Continuous coordination with media specifically QTV 11's "The Reunions" for the reintegration of clients to their families. In which 3 clients (with 1 minor girl) were reintegrated with their respective families in Laoag and Bataan Cities.
- On health concerns, the Dietary Unit conducted weighing and assessment on the nutritional status of the One Hundred Sixty-Eight (168) clients of JFC (for the period of January to March 2010). Wherein, 30 clients were assessed as below normal (22 were minor and 8 adult clients), 16 above normal and 122 clients were assessed to have a normal nutritional status.
- Conducted a health lecture on Kidney Functions and Common Kidney Diseases to 135 clients and 15 staff on September 13, 2010. The lecture aims to instill awareness and information to the clients about the importance of kidney and the diseases it could acquire if not properly taken care of.
- A total of Ninety-six (96) clients including minors, Persons with disabilities and mentally challenged were engaged in productivity service such as repair of damaged pillow cases and pants of clients thru hand sewing, cloth de-threading, Origami,

Flower paper and doormat projects. These activities were able to help developed the skills of the clients that can help them on their eventual family reintegration.

- A total of Seventy-five (75) participated in gardening activities within the center's perimeter. For this quarter, there were 50 kilos of camote tops, 15 kilos of okra and 15 kilos of kangkong harvested to augment the limited budget and resources of the center.
- Continuously conducting early warming exercise such as jogging, volleyball and basketball to help the clients to be physically fit and as preparation for the center's 40th Anniversary.

Reception and Study Center for Children (RSCC)

Cumulatively, the Center has already served 113 children for CY 2010 or 73% of its annual target which is 154. Among these clients, 22 are newly admitted including those who were neglected (7), abandoned (6), physically abused (2), voluntary committed (1) and those under protective custody (6). For this quarter, 16clients were discharged with the following breakdown: 10 were reunited with their families / relatives, 2 were placed in inter country adoption, 2 were placed for foster family care, 1 was transferred to other institution and 1 died.

Among the highlights of accomplishment of RSCC for this quarter are the following:

- On health, the center's Dietary Unit conducted close monitoring on the nutritional status of the children and was able to assess One Hundred One (101) children for the said quarter. In which 16 of them were identified as below normal, 1 above normal and 84 were assessed to have a normal nutritional status.
- Mass baptism of twenty-Four (24) children was conducted in accordance with catholic rites as part of the center's 46th Anniversary celebration held on July 30, 2010.
- Continuous tapping and coordination with different People's Organization (PO) for the gardening and beautification of the center's premises. Wherein, staffs of Quezon City Parks and Wildlife helped in grass cutting and trimming of ornament plants and trees while the Divine Healer Community group volunteered in tree planting of fruit bearing trees and vegetable seedling like eggplants, papaya and camote tops.
- Conducted Drawing Contest and Declamation (Pagbigkas ng Tula) as part of the "Buwan ng Wika" celebration, in which thirty-one children participated in the said activity.

Haven for Children (HC)

As of the 2nd Quarter of CY 2010, Haven for Children was able to served 125 clients or 63% of its annual target. Among these clients 7 persons were new clients, all categorized as street children. On the other hand, a total of 8 clients were discharged from Haven for Children for this quarter alone through reintegration with their families / relatives (7) and transfer to other institution (1).

Among the highlights of accomplishment of HC for this quarter are the following:

- On health concern, the Dietary Unit was able to weigh and assessed the nutritional status of 86 children in Haven for Children (for the period of April to June 2010). In which, 15 were assessed as below normal and 71 as normal however, after 3 months he 15 clients who were assessed as below normal was rehabilitated to normal status and the 71 children maintained their normal nutritional status.
- A total of Sixty (60) children attended skills training on carpentry, candle making, silk screening and dream catcher making under the supervision of the center's Manpower Development Officer (MDO). These skills training enable the children to acquire basic skills in arts and craftsmanship that can be a source of income in the future.
- Continuous partnership with volunteer individuals such s Mrs. Lourdes Baculin and Ms. Sandra for the tutorial sessions of the children once a week.
- Close coordination/ partnership with volunteer priest and seminarians were continuously conducted. Wherein, identification and preparation of children for baptism and first communion was done and was scheduled on October 2010 in accordance with catholic rites.

INA Healing Center (IHC)

Among the highlights of Accomplishment of IHC for this quarter are as follows:

- A total of twenty (20) clients undergone grief recovery program with inclusion of the topics on HIV and AIDS, Disaster Preparedness and Health and Nutrition.
- Continuous tapping/mobilization and close coordination with other agencies/ organizations such as the Art of Living to share their available services as well as necessary information on healthy life style for the bereaved mothers. There were twenty-three (23) mothers who were provided Breath and Sound Relaxation Therapy which had increase the mothers' leaning on proper breathing and awareness to the life's sources energy that can help in nourishing our body and relieved us from stress.

Sanctuary Center (SC)

SC has served a total of 162 clients as of the third quarter of CY 2010. In other words they have already served 162 clients or 95% of the annual target. Out of the clients, 18 of them are new cases involving improved mental patients.

Among the highlights of accomplishment of SC for this quarter are the following:

- A total of Fifty-six (56) functional clients involved in productivity activities such as beads making, sewing, and gardening while 35 clients are involved in other therapeutic activities such as sing, dance and functional therapy and others that suffice needs of the clients as part of their rehabilitation while at the center.
- In observance of Nutrition Month, lecture/discussion about Vitamins to all clients and cooking contest to 35 clients and staff were held on July25, and July 28, 2010

respectively. The said activities were able to instill information and awareness to the clients on the importance of nutrition as well as how to prepare nutritious foods

Haven for Women (HW)

Among the highlights of accomplishment of HW for this quarter are the following:

- A total of Ninety-one (91) clients and staff participated in various skills training activities such as stuff toys making, actual hands-on in basic sewing, bag making, rug and pot holder making and beads making, wherein 19 clients already have a subcontract on beads making. Such skills trainings enable the clients to enhance their skills that can be possible source of income once reintegrated to their families.
- In observance of Nutrition Month, a kick-off parade participated by Sixty (60) clients and Twenty (20) staff was conducted on July 5, 2010 followed by poster making contest which was participated by Nine (9) clients was held on July 16, 2010 and Cooking demo/ contest participated by Nine (9) clients and Fifteen (15) staffs held on July 29, 2010. These activities were able to instill awareness to the clients on the importance of nutrition and it also serves as a venue to showcase their talent in arts through poster making and cooking.
- In observance of Disaster Consciousness Month, an Earthquake Drill and Lecture on Disaster risk Management was conducted to Thirty-Four (34) clients and Six (6) staff last July 29, 2010. The said activities provided information to the clients and staff on safety measures/ precaution on disaster occurrences.
- A total of Fifty-One (51) clients were able to experience a one-day swimming treat at the Garden Resort in Alabang, Muntinlupa held last Aug. 8, 2010 which was sponsored by Ms. Cynthia Villar. The said activity served as a relaxation to the clients and another opportunity to build camaraderie to other co-clients and staff outside the center's premises.
- Continuous mobilization/tapping and coordination to other agencies/ corporations such as GE Electronics in which forty (40) clients of the center were invited to their office in Northgate for a film viewing on maternal and child care and lunch treat held last September 5, 2010.
- In celebration for the center's 15th Year Anniversary, a kick-of parade was conducted by the center's clients and staff along the streets of Alabang-Zapote with the special participation of Muntinlupa Brass Band followed by a talent competition dubbed as "Haven Got Talent" that provides opportunity for the clients to showcase their talents.

Center for Restorative Activities, Development and Learning Experiences (CRADLE)

Among the highlights of accomplishment of CRADLE for this quarter are the following:

• Continuously conducting Alternative Learning System (ALS)/ informal education provided by DepEd to fifty-six CICL in which 16 CICL were enrolled in basic literacy, 12 on elementary level and 28 in secondary level. The informal classes were

- scheduled every Monday and Tuesday. It aims to provide the clients the education they needed despite of the circumstances that they are experiencing.
- Continuous mobilization/tapping and collaboration with other agencies/ organizations such as CARITAS Manila and ACE International who provided values formation, spiritual enhancement and livelihood training on rug making to 58 CICL clients. The said activities deepen their faith as well as enable them to acquire new skills especially in rug making.

National Vocational and Rehabilitation Center (NVRC)

As of this quarter, NVRC has already served 147 clients or 111% of its annual target of 132. Out of the total persons served, 25 are new clients for the quarter alone. These clients were either orthopedically handicapped (1), speech / hearing impaired (14), visually impaired (4), improved mental patient (2), Down syndrome (1) or dependent (3).

Among the highlights of accomplishment NVRC are the following:

- Two (2) clients who were both orthopedically impaired were job placed as encoders at Zest-Air Airlines
- In observance of "Buwan ng Wika", a "Lakbay Aral" tour was conducted at Quezon Memorial Monument on August 24, 2010, wherein 20 PWD trainees participated and explore different artifacts. The tour serves as an opportunity for the clients to learn additional information about our country, our presidents and national heroes. It also serves as a venue to instill nationalism to the clients.

Elsie Gaches Village (EGV)

As of the 3rd quarter of CY 2010, there were already 617 PWDs served by EGV which is 95% of its annual plan already. Among these clients, there are two (2) new cases where one (1) is mentally-challenged client while the other one (1) is a visually-impaired client.

Among the highlights of accomplishment of EGV for this quarter are the following:

- A total of Fifty-nine (59) upper trainable clients were trained in different productivity projects such as arts and craft, origami etc. as part of therapy activities and skills training. Through this, the clients improved their skills in craftsmanship and develop work related values. Further, finished products were displayed/ placed in the Souvenir Shop which is saleable to visitors and sponsors.
- A total of twenty (20) selected clients attended a retreat on Psychogenetics and Gestalt Therapy held on July 20, 2010 by the Gabay sa Paghilom Foundation. The participants of the said training were able to learn more about values and interaction with other people.
- In observance of the Disaster Consciousness Month and Buwan ng Wika, various activities were conducted among the One Hundred Eight (108) Special education (SpEd) students such as Drawing Contest with theme "Pag Alerto, Malayo sa

Peligro", and Riddle Contest dubbed as Tagisan ng Talino sa Bugtong. These activities aim to reinforce and strengthen the learning of the clients on the specific subject matter.

- Continuous conduct of sports activities such as basketball, volleyball and other outdoor games as venue for physical fitness, development of stamina and dexterity, honing skills along specific sports, inculcation of values aside from its therapeutic gains.
- A total of twenty-eight (28) clients attended the Family Day Fun held at SM Skydome on July 17, 2010 in celebration to the National Disability Prevention and Rehabilitation Week which serves as an opportunity to the clients to meet and relate to other people.

Marillac Hills (MH)

Marillac Hills has served 85% of its annual target or 288 persons as of the third quarter of CY 2010. Among this figure, 26 clients are new cases for the quarter. Cases of sexual abused was the most prevalent among the new cases with 8 persons followed by cases on children in conflict with the law (6), child trafficking (3), cyber pornography (1), special custody arrangement (1), unwed mothers (1) and dependent babies (3).

Among the high lights of accomplishment of Marillac Hills are the following:

- A total of One Hundred Forty Six (146) clients were provided skills training to wit: 46 clients in basic computer, 42 in cosmetology, 26 in hi-speed sewing level I and 14 in level II and 28 in baking. These skills training were able to help the clients to gain knowledge, acquire skills and develop positive attitude in working.
- In observance of National Nutrition Month, various activities were conducted such as sharing of nutrition and health information during flag ceremony, cooking demo, children parade and Nutri-house contest which participated by 128 children. These activities serve as a venue to instill awareness on the importance of good nutrition as well as to enhance their creativeness and showcase their talent in cooking.

Nayon ng Kabataan (NK)

As of the third quarter of CY 2010, they were able to serve 240 clients or 80% of the annual target of 300. Among the persons served, 31 clients are newly admitted for the 3rd quarter. Categories of these clients vary from neglected (18), victims of child labor (7), physically-abused (3) and victims of trafficking (3). For the quarter alone 26 persons were discharged from the center either by reintegration with their families / relatives (15), left without permission (5), home wage placement (3), transferred to other institution (2) or mortality (1).

Among the highlights of accomplishment of NK for this quarter are the following:

• On productivity, three (3) female clients were trained in Beauty Care and Body Treatment such as facial massage, express clarifying, full scrub, hand and foot spa

etc., while four (4) others were trained as hairdresser and will eventually undergo a one month On the Job Training (OJT) to different Reyes Haircutters Salon. Further, 2 clients are continuously working in Miyata Electronics Company and have regular earnings. The said skills training and work provided enable the clients to be productive and develop their skills in their chose field.

- On productivity production and income generation, ten (10) clients who were trainees for dressmaking was able to produce 10 pieces of pot holders, 15 pieces bed sheets, 16 pieces of pillow case, 13 pieces of throw pillow case, 8 pieces hand bags and 120 pieces small round rugs. Most of the said products were already sold and the income generated was used to purchase materials for use in the production of different sewing products or sale. While, there were five (5) clients involved in food production and were able to generate income amounting to 1,200.00.
- Continuous mobilizing/tapping and coordination with other agencies/ organizations such s KOPHARMTEENS Group and UNICEF among others wherein KOPHARMTEENS conducted a gift giving to One Hundred Fifty Seven (157) children held at the center's covered court last July 16 and 18, 2010. While UNICEF conducted a center visit and provided footballs, socks, shirts and shorts to the 32 players of NK Soccer Team and distributed snacks to 157 children last July 10, 2010. The children were able to nurture the value of appreciation to the blessings that they received.
- In observance to the Family Week Celebration, the center conducted a One-day Family Activity wherein parents and relatives of the clients were invited to witnessed and join the Mass Baptism conducted by Father Wilmer Rosario of Sacred Heart Parish and fun games held last September 19, 2010.

F. INSTITUTIONAL STRENGTHENING

For the 3rd quarter, thru the Human Resource Management Unit, out of the seven (7) target trainings for internal staff, five (5) or 71.427% were conducted while the remaining two (2) targeted training did not materialize because there is a need to review further the content of the module and plans were not prioritized due to prioritizing of more urgent intervening activities. From the five (5) conducted trainings, a total 125 or 63.77% vis a vis 196 of the target participants attended the trainings. These are the following:

- 1. Livelihood Capability Enhancement for Project Development Officers
- 2. Training on Training Development and Management cum Technical Documentation
- 3. Orientation on HIV and AIDS in the Workplace
- 4. Sensitivity Training on Handling Women in Difficult Circumstances cum Skills Enhancement on Anger Management
- 5. Roll Out Training of Implementers on Care and Support Services for PLHIV and their Families

The above-mentioned trainings were conducted based on the identified Training Needs Inventory of the staff.

Further, a total of 338 internal staff or 43.61% vis a vis 775 target staff were able to achieved a minimum of 24 hours training required per year per Civil Service Rule.




Staff Complement per Source of Funds:

Meanwhile, to complete the staff requirement of the Region, a total of 125 vacant positions still to be filled up: forty (40) regular positions, eighty-four (84) MOA and one (1) Contractual.

To augment the manpower of the Region, a total of seventy-one (71) staff were also hired/detailed at the Region., Cost of Service of these employees were being funded by private sponsor or by their Agency such as detailed teachers from Department of Education. Breakdown as follow:

Donations Received

For the quarter, the centers/institutions/units have generated a total amount of **Php 4,582,965.56** in cash and in kind donated by partner agencies, stakeholders and private institutions.

With the total amount of resource generated thru MOA/partnership with other agencies and donation received, a total amount of **Php 5,477,178.49** or 3% have generated by the Region to supplement the regional expenses against **Php 182, 239, 749.630** the total expenses of the quarter.

Meanwhile, in the different centers, institutions and units of the Region, they had conducted orientations of programs and services of their respective C/Is to students, volunteers and other stakeholders as part of the social marketing undertaken of the concerned C/I/Us.

Management Information System

For the 3rd quarter, the Regional Management Information Unit of the region has effectively provided the ICT services needed by the region as follows:

- Monitored functionality of internet connection on all FO units especially those implementing E-Services such as Adoption Resource and Referral Unit, Travel Clearance Unit and Standards Unit
- Assisted the implementation of Crisis Intervention Monitoring System (CRIMS) for Crisis Intervention Unit and National Household Targeting for Poverty Reduction System and 4Ps in the utilization of network system.

- Assisted the Social Marketing Unit in updating the homepage of the regional website.
- A total of 477 or 98.14% out of 486 total number of ICT equipment were maintained. The remaining nine (9) or 11.14% needs upgrading, replacement or repair and maintenance from outsider/ supplier. Out of the nine (9) ICT equipment, there were two (2) units of computer which needs to be upgraded due to slow performance and met its years of service, two (2) units of computer for replacement of power supply, two (2) LCD monitor for repair while three (3) printer units for repair outside/ supplier.
