Narrative Report

I. STATISTICAL REPORT

For CY 2013, the following C/I/U's reported that they were able to serve a total of covering the period of January-December 2013.

II. HIGHLIGHTS OF ACCOMPLISHMENTS

- ❖ As reported for CY 2013, the DSWD-NCR C/I/U's have had 397 TIP cases served. Out of the 397, 179 were served by the Haven for Women, 27 served by Marillac Hills, 24 served by Nayon ng Kabataan, and 167 were served by the Community Based Service Section (CBSS).
- ❖ Haven for women reported that out of 179 they have served, 165 were reintegrated to their respective families and the other 14 were still at the center.
- ❖ Marillac Hills reported that they have had served 27 TIP victims survivors. 2 of which were reintegrated to their families after a favorable Parenting Capability Assessment while the other 25 were at the center.
- ❖ Nayon ng Kabataan have had served 24 TIP clients wherein 8 were reintegrated to their families and the other 16 were still at the center.
- ❖ CBSS was able to serve a total of 167 TIP victims-survivors. Out of the 167 TIP, 58 were provided Livelihood Assistance, 44 were provided Transportation Assistance in going back home to their respective provinces while the rest were endorsed to FO for aftercare/monitoring and provision of Livelihood Assistance under the Recovery and Reintegration Program for Trafficked Persons.
- ❖ For this year, the CBSS facilitated the 1st, 2nd, 3rd and 4th batches of Basic Business Management Training (BBMT) for TIP victims eligible to avail Livelihood Assistance in the amount of Ten Thousand pesos (10,000.00) under the Recovery and Reintegration Program for Trafficked Persons (RRPTP). The 1st batch of BBMT was held on April 22, 2013 with 12 participants. The 2nd batch of BBMT was held on July 29, 2013 with 16 participants at the Visayan Forum Foundation, Inc. All of these clients already availed Livelihood Assistance. The 3rd and 4th batch was dated October 10, 2013 from 8:00am-5:00pm at Samaritana Ministries, Inc. with 24 participants and October 22, 2013 at OSEC Conference Room with 29 participants.

- ❖ Also for this year, there were 7 rescue operations conducted by the composite team of NBI, CIDG-ATCD, IJM and DSWD-NCR. For the month of July 2013, there were 2 rescue operations ensued dated July 19-20 at Infinity Bar with 47 TIP victims rescued and on July 27-29 at Asian entertainment Network with 89 TIP victims-survivors rescued. On August 29-30, a rescue operation was conducted at Marikina River Park were 5 victims were rescued. Then on September 3-4 2013, there were 4 minors rescued at C5 Road, Taguig City. For the month of October 2013, 2 rescue operations were conducted dated October 1 were the NBI and DSWD-NCR rescued a child victim of child labor in quezon City and on October 11-13, 013, 47 adults were rescued at Chaparral Club in Quezon City. For the month of November, there were 74 TIP's rescued at Fairy's Touch in Roxas Blvd., Pasay City. All of the rescued TIP's were endorsed to their respective DSWD FO's and LGU's for aftercare/monitoring and provision of Financial and Livelihood Assistance under RRPTP.
