I. STATISTICAL REPORT

For CY 2014, the following C/I/U's reported that they were able to serve a total of covering the period of January-December 2014.

II. HIGHLIGHTS OF ACCOMPLISHMENTS

- ❖ As reported for CY 2014, the DSWD-NCR C/I/U's have had 858 TIP cases served. Out of the 858, 200 were served by the Haven for Women, 43 served by Marillac Hills, 26 served by Nayon ng Kabataan, 275 served by NAIA- Task Force Against Trafficking Persons and 314 were served by the Community Based Service Section (CBSS).
- ❖ Haven for women reported that out of 200 they have served, One Hundred Twenty Two (122) were already reintegrated to their families, One (1) client was transferred to Marillac Hills, Nine (9) leave without permission, Four (4) were provided transportation assistance in going back to their province while Sixty Four (64) were remained at the center.
- ❖ Marillac Hills reported that they have had served Forty three (43) TIP victims survivors. 5 of which were reintegrated to their families after a favorable Parenting Capability Assessment while the other 38 were at the center.
- Nayon ng Kabataan have had served Twenty Six (26) TIP Clients covering the period of July-December 2014. Out of 26, Eighteen (18) with filed case while Eight (8) are still awaiting for the Parental Capability Assessment Report of their respective families.
- ❖ CBSS was able to serve a total of Three Hundred Fifteen (314) TIP Clients. Out of 314, One Hundred Thirty Six (136) were assisted from rescue operation, One Hundred Twenty One (121) were provided livelihood Assistance, Twenty (20) were also provided transportation assistance in going back to their respective provinces while the rest were recommended for Livelihood Assistance under Recovery and Reintegration Program for Trafficked Persons.
- ❖ NAIA-Task Force Against Trafficking Persons (NAIA-TFATP) have had total of Two Hundred Seventy Five (275) TIP Clients assisted and provided airport assistance such as intake interview, counseling and referred for temporary shelter to center registered and accredited by DSWD-NCR.
- ❖ For this Year covering the period of January 13, 2014-December 11, 2014, there were Fifty Six (56) rescue operations conducted by the composite team of NBI-AHTRAD, CIDG-ATCU, NBI-NCR, IJM and DSWD-NCR. There were Six Hundred Fourteen (614) rescued victims. Out of 614, there were Two Hundred Thirty Nine (239) referred to DSWD Care Facilities: Forty Six (46) were referred to Marillac Hills, Thirty One (31) were referred to Nayon ng Kabataan, One Hundred Fifty Three (153) were referred to haven for Women and Nine (9) were referred to

Visayan Forum Foundation Incorporated while Three Hundred Seventy Five were already discharged and all are endorsed to their respective LGU's for aftercare services and monitoring and also for provision of Financial and Livelihood under RRPTP Funds.

For this year, the CBSS facilitated the 1st, 2nd, 3rd and batches of Basic Business Management Training (BBMT) for TIP victims eligible to avail Livelihood Assistance in the amount of Ten Thousand pesos (10,000.00) under the Recovery and Reintegration Program for Trafficked Persons (RRPTP). The 1st batch of BBMT was held on June 27, 2014 with 6 participants. The 2nd batch of BBMT was held on November 27, 2014 with 17 participants at Karunungan Conference Room, DSWD-NCR. The 3rd and 4th batch was dated November 29, 2014 from 8:00 – 12:00 pm at Coalition Against Trafficking in Women-Asia Pacific located at Quezon City with 16 participants. All of these clients were already provided livelihood Assistance under RRPTP Funds.
