ADDENDUM TO REGIONAL MEMORANDUM ORDER NO. 002 SERIES OF 2019 OR THE GUIDELINE IN UTILIZATION OF RESEARCH FINDINGS AND RECOMMENDATIONS CONDUCTED IN THE FIELD OFFICE OF NCR.

I. Functions of Research Focal Person

A. During the conduct of Data Gathering Activities in their respective D/C/RCF/S/Us.

- Shall monitor all the research activities in their respective D/C/RCF/S/Us in coordination with the concerned services. Likewise, ensure that students/ researchers are provided with necessary orientation on C/RCFs rules and regulations.
- 2. Shall ensure that the students/ researchers are provided with necessary orientation on C/RCFs rules and regulations most especially privacy policy of the respective C/RCFs in compliance to Data Privacy Act of 2012.
- 3. Submit feedback reports to PDPS regarding the conduct of data-gathering activities in their D/C/RCF/S/Us five days after the completion of the data-gathering.
- 4. Participate in exit conferences together with the staff involved during the conduct of data-gathering activities.
- 5. Shall ensure maintenance of files of research activities conducted in their respective D/C/RCF/U/Ss.

B. Utilization and Monitoring of Research Findings and Recommendations in their respective D/C/RCF/S/Us.

- 1. Oversee / monitor the compliance/ utilization of their D/C/RCF/U/Ss to all the research findings and recommendations forwarded to their respective offices.
- 2. Prepare the report on their compliance/ utilization to the findings and recommendations using the prescribed template (Research Compliance Monitoring Matrix).
- 3. Submit the reports at the end of each semester duly endorsed by the Head of their respective D/C/RCF/ S/Us to the Regional Director thru Policy Development and Planning Section.

C. Conduct of Region Initiated Researches

When deemed necessary Research Focal Person from D/C/RCF/S/Us may be directed to participate and assist in the data gathering activities for region initiated researches /study to be conducted.

II. Effectivity

This order shall take effect immediately. Let copies of this Regional Memorandum Order be given to all DSWD-NCR RCF/Division/Unit/Section.
