SUPPLY AND DELIVERY OF FOODSTUFF REQUIREMENTS OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT – NATIONAL CAPITAL REGION (DSWD-NCR) FOR RESIDENTIAL CARE FACILITIES (RCFs) FOR THE SECOND (2ND) SEMESTER OF FY 2021

1. The Department of Social Welfare and Development – National Capital Region through the Direct Release Funds intends to apply the sum per lot with the following breakdown as follows:

LOT 1: Vegetables, Fruits and Other Miscellaneous

Contract Amount: **Php11,804,086.26**

LOT 2: Fish and Other Seafoods

Contract Amount: **Php7,294,884.00**

LOT 3: Meat/Pork and Beef

Contract Amount: **Php14,054,664.00**

LOT 4: Chicken and Eggs

Contract Amount: **Php6,215,822.40**

LOT 5: Canned Goods and Other Grocery Items

Contract Amount: **Php9,016,788.40**

being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC FOR EACH LOT shall be automatically rejected at bid opening. Late bids shall not be accepted.

2. The DSWD-NCR now invites bids for the **Supply and Delivery of Foodstuff Requirements of the Department of Social Welfare and Development (DSWD-NCR) for Residential Care Facilities (RCFs) for the Second (2nd) Semester of FY 2021**. Delivery of Goods and Services shall be in accordance with **Section VI. Schedule of Requirements**. Bidders should have completed **within the last three (3) years from the date of submission and receipt of bids**, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country, the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Prospective bidders may obtain further information from DSWD-NCR Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from Monday to Friday at 8:00AM to 5:00PM.
5. A complete set of Bidding Documents may be purchased by interested Bidders from **20 April 2021 to 10 May 2021; (April 20 to May 7, 2021; 8:00AM to 4:00PM)(May 10, 2021: until 9:30AM only)** from the address given below and upon payment of a refundable fee in accordance to Section 17.5 of the IRR:

The DSWD-NCR BAC will hold a **Pre-Bidding Conference on 27 April 2021; 10:00 A.M. at DSWD-NCR-Rehabilitation Sheltered Workshop (RSW), J.P Burgos Street, Project 4, Quezon City** and through video conferencing via google meet (meet.google.com/prk-nrcs-bim) which shall be opened to all interested bidders.
7. Bids must be received by the BAC Secretariat at the address below on or before **10 May 2021, 9:45 A.M. at DSWD-NCR-Rehabilitation Sheltered Workshop (RSW), J.P Burgos Street, Project 4, Quezon City**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
9. Bid opening shall immediately follow after the deadline of the submission and receipt of bids shall be on **10 May 2021, 10:00 A.M. at DSWD-NCR-Rehabilitation Sheltered Workshop (RSW), J.P Burgos Street, Project 4, Quezon City** Bids will be opened in the presence of the Bidder's representatives who choose to attend.
10. The DSWD-NCR reserves the right to accept or reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of RA 9184 and its 2016 Revised Implementing Rules and Regulation (IRR), without thereby incurring any liability to the affected bidder or bidders.


