

# RESOLUTION IN THE FILING AND SUBMISSION OF STATEMENT OF ASSETS, LIABILITIES AND NETWORTH (SALN) AS OF DECEMBER 31, 2022 OF DSWD-NCR EMPLOYEES

WHEREAS, the Department of Social Welfare and Development (DSWD)-NCR has formally adopted the SALN Referendum No. 2022 – 01 or "Review and Compliance Procedure in the Filing and Submission of Statement of Assets, Liabilities and Networth (SALN) as of December 31 of every year and their disclosure";

WHEREAS, the SALN Review and Compliance Committee convened on June 09, 2023 to conduct the final review and evaluate the SALN forwarded by Personnel Administration Section (PAS) if the same has been submitted on time, complete and in proper form:

WHEREAS, the SALN Secretariat presented the final list of employees covered by RA 6713 also known as "An Act Establishing a Code of Conduct and Ethical Standards for Public Officials and Employees, to Uphold the Time-honored Principle of Public Office being a Public Trust, Granting Incentives and Rewards for Exemplary Service, Enumerating Prohibited Acts and Transactions and Providing Penalties for Violations thereof and for Other Purposes," who filed and did not file their SALN within the prescribed timeline of submission which was on January 31, 2023. It was further extended until February 28, 2023 through an official memorandum dated February 15, 2023 to allow sufficient time for concerned employees to comply with the requirement;

WHEREAS, as of December 31, 2022 the total warm bodies of Field Office – NCR is One Thousand Three Hundred Sixty-one (1,361) who are covered by the RA 6713 and are required to submit their accomplished SALN for CY 2022 as per the Section 17, Article XI of the 1987 Philippine Constitution;

WHEREAS, following the consolidation of the SALN Secretariat, out of the One Thousand Three Hundred Sixty-one (1,361) FO-NCR staff, the final list of filers for the SALN included are the One Thousand Three Hundred Fifty-nine (1,359) permanent, contractual, and casual personnel as of June 09, 2023 (attached is the Annex A);

WHEREAS, a total of two (2) separated contractual staff namely, Mr. Arnold Gumangan (dropped from the roll) and Ms. Ria Coquilla (resigned), both Project Development Officers II of Field Office – NCR did not file their respective SALN for CY 2022. Despite several efforts by the PAS by all means of communication and efforts, still there were no response from either or both of them.

WHEREAS, upon deliberation of the SALN Field Office Review and Compliance Committee, it is hereby agreed that despite of the non-submission of the two (2) staff, DSWD-NCR will submit all the filed SALN within the prescribed timeline to the Office of the Ombudsman.

NOW THEREFORE, it is hereby RESOLVED through this Resolution to submit the SALN of FO-NCR to the Office of the Ombudsman on June 15, 2023.
